Employee, Committee & Ward reports were heard.

Public Input: Judy Heth asked about locating utilities prior to construction starting by her property.

Second reading of Ordinance 384-2; rezone Lot 1 Thorpe Addn was held. Motion by Grabow, second by Nosbush to adopt. Roll call vote, all aye; carried.

Second reading of the 2026 Appropriation Ordinance #386 was held. Motion by Engesser, second by Nosbush to adopt. Roll call vote, all aye; carried.

Motion by Nosbush, second by Grabow to accept the proposal from Ben Elliott, CPA to complete the 2025-year end audit for a fixed rate of \$6,500. All voting aye; carried.

With the low price of cardboard recycling, we no longer have anyone to pick up at our location. Council discussed the option of hauling the trailer to Clear Lake, returning with an empty one for continued use. Maintaining a cardboard trailer is important to keep cardboard out of the garbage truck. Motion by Grabow, second by Schumacher to haul the trailer to Clear Lake as needed. All voting aye; carried. Please be sure to break down boxes and stack neatly to maximize trailer space.

Kellen Marson & Bob Bauman representing Clear Lake Baseball Association spoke to the Council about an opportunity to host baseball games at Legion Field. After a lengthy discussion, no decision was made but will be revisited at a future meeting.

Motion by Nosbush, second by Engesser to fill the propane tanks at the Firehall, Liquor Store and City Hall utilizing the summer fill rate @ \$1.49 with Deuel County Farmers Union and contract 2,000 gallons at \$1.59. All voting aye; carried.

Motion by Engesser, second by Nelson to accept the 2026 Law Enforcement contract with Deuel County. All voting aye; carried.

Motion by Nosbush, second by Engesser to approve the letter of acceptance from the DLA for the 2024-year end Audit. All voting aye; carried.

Motion by Grabow, second by Nelson to renew the Video Lottery License for 2026 at the Gary Liquor Store. All voting aye; carried.

The fifth payment request from the State Revolving Fund loan in the amount of \$199,574 was approved to send in with a motion by Nelson, second by Grabow. All voting aye; carried.
